

Ola Ice Cream Factory Festival promotion (existing customers) - Terms and conditions

1. Eligibility

- 1.1. Entry is open to all Ola customers located in Perth, Western Australia during the promotion period or part thereof, who are 18 years of age or older (the “**eligible entrants**”).
- 1.2. Employees of the promoter, immediate family members of employees and employees of any company associated with the promotion are ineligible to enter.

2. Entry

- 2.1. The promotion commences at 00:00 AWST on 10 December 2019 and entries close at 09:00 AWST on 11 December 2019 (the “**promotion period**”).
- 2.2. To enter, eligible entrants must, all during the promotion period, follow Ola Australia on Instagram, at https://www.instagram.com/ola_australia/ and comment on an Instagram post posted by Ola Australia in relation to the Ice Cream Factory Festival (the “**eligible entry**”).
- 2.3. Ola standard customer terms and conditions and any other applicable terms and conditions apply.

3. Prizes and winning

- 3.1. There are fifty two (52) prizes in total.
- 3.2. Each prize consists of one (1) double pass to one day of the 2019 Ice Cream Factory Festival.
- 3.3. The breakdown of the prizes per days/dates of the Ice Cream Factory Festival is as follows:
 - (a) 15 double passes - 13 December 2019;
 - (b) 5 double passes - 15 December 2019;
 - (c) 5 double passes - 19 December 2019;
 - (d) 5 double passes - 24 December 2019;
 - (e) 10 double passes - 28 December 2019;
 - (f) 12 double passes - 29 December 2019.
- 3.4. Winners will be selected by running a list of all eligible entrants who made an eligible entry through the Random.org List Randomizer.

- 3.5. The first fifty two (52) eligible entrants with an eligible entry listed by the List Randomizer will each win a prize.
- 3.6. The prizes will be won/distributed based on the eligible entrants' list position on the list generated by the List Randomizer, as follows:
 - (a) list position 1-15 - 13 December 2019 double pass;
 - (b) list position 16-20 - 15 December 2019 double pass;
 - (c) list position 21-25 - 19 December 2019 double pass;
 - (d) list position 26-30 - 24 December 2019 double pass;
 - (e) list position 31-40 - 28 December 2019 double pass;
 - (f) list position 41-52 - 29 December 2019 double pass.

4. Prize conditions

- 4.1. Entrants who win a prize will be notified by Instagram direct message (DM) and/or an Instagram comment within one business day of the end of the promotion period.
- 4.2. The prize winners may have their details published on Ola Australia website located at <https://ola.com.au/> and/or on Ola Australia Instagram page following the end of the promotion period.
- 4.3. The prizes will be delivered electronically, in the form of electronic tickets sent to the winners' email addresses.
- 4.4. Any prizes unclaimed or unable to be delivered to the prize winners due to incorrect names, email addresses or any other reason outside the direct control of Ola will be forfeited.
- 4.5. The prizes and the use of the prizes, including, but not limited to, the expiry of the prizes, will be governed by the issuer of, and terms and conditions applicable to, the tickets (passes).
- 4.6. The prizes cannot be taken, used or combined with any other offer, discount, prize or promotion.

- 4.8. Any prizes transferred or sold will be cancelled.
